- (2) On October 7, 2005, the JL Trust (as defined below) distributed 1,418,976 shares of Class B Common Stock to the Trust f/b/o Jane A. Lauder u/a/d November 6, 2003 created by Jane A. Lauder, as grantor.
- (3) After this transfer, the amount of Class B Common Stock beneficially owned by the Reporting Person is 2,843,002, which includes 1,402,090 in the AL Trust (as defined below) and 1,440,912 in the JL Trust (as defined below).
