  - (1) Award by the board of directors of 20,000 shares of restricted stock to Mr. Weed on January 1, 2008. 25% of the award will vest on January 1, 2009 and 6.25% of the award will vest quarterly thereafter until fully vested after 12 quarters on January 1, 2012. Vesting will accelerate on change of control and death or disability.
  - (2) This exercise and sale of options to acquire 280 shares of common stock for an aggregate purchase price of \$0.07, or \$0.00026 per share was implemented pursuant to Mr. Weed's structured sale plan (10b5-1 plan).
