Elliott International and International Advisors together beneficially own the 25,985,476 Ordinary Shares held by Elliott International. Elliott International owns its 25,985,476 Ordinary Shares through DIP Holdco 5 Ltd., a Cayman Islands company and a wholly-owned subsidiary of Elliott International.

Elliott Associates, Elliott International and International Advisors together beneficially own an aggregate of 42,182,430 Ordinary Shares.

(b) Percent of class:

Elliott Associates' ownership of 16,196,954 Ordinary Shares constitutes 4.9% of all of the outstanding Ordinary Shares.

Elliott International and International Advisors' aggregate beneficial ownership of 25,985,476 Ordinary Shares constitutes 7.9% of all of the outstanding Ordinary Shares.

Elliott Associates, Elliott International and International Advisors' aggregate beneficial ownership of 42,182,430 Ordinary Shares constitutes 12.9% of all the outstanding Ordinary Shares.
