At the 2005 Annual Meeting of Stockholders held on May 9, 2005, proposed amendments to the 1996 Stock Retainer Plan for Non-Employee Directors were approved. The amendments, among other things, change the name of the Retainer Plan to better reflect the purpose and intent of the Retainer Plan, provide for the mandatory (rather than voluntary) deferral of director fees, and provide that all shares of Company Common Stock used to pay director fees be acquired on the open market, rather than originally issued by the Company. A copy of the Retainer Plan as amended and restated is attached to this Report on Form 8-K as Exhibit 10.1 and is incorporated herein by reference.
