These performance share units, which provided for vesting in one installment on or before February 28, 2011, subject to achievement of

(6) performance goal, were cancelled and disposed of pursuant to the Merger Agreement in exchange for \$31.50 in cash for each share of the Issuer's common stock subject to such performance share units.
