Item 2.02. Results of Operations and Financial Condition

Explanatory note: Pioneer Natural Resources Company and its subsidiaries ("Pioneer" or the "Company") presents in this Item 2.02 certain information regarding average realized prices and the impact of changes in the fair values of derivative instruments on its results of operations for the three and twelve months ended December 31, 2014 and certain other information regarding its derivative instruments.

The following tables detail the components of average realized prices and net derivative gains that Pioneer expects to report in its earnings for the three and twelve months ended December 31, 2014. Given the significant volatility that occurred in oil, natural gas liquids and gas prices during the fourth quarter of 2014, average realized prices have been included in this Report to quantify the impact to the fourth quarter and annual results of operations in advance of Pioneer's fourth quarter 2014 earnings press release (expected February 10, 2015).

Counterparties have the option to extend 5,000 BBLs per day of 2015 collar contracts with short puts for an (a) additional year with a ceiling price of \$100.08 per BBL, a floor price of \$90.00 per BBL and a short put price of \$80.00 per BBL. The option to extend is exercisable by the counterparties on December 31, 2015.

(b) Represent swaps that fix the difference between (i) each day's price per Bbl of West Texas Intermediate oil "WTI" for the first nearby month less (ii) the price per Bbl of WTI for the second nearby NYMEX month, multiplied by

.6667; plus (iii) each day's price per Bbl of WTI for the first nearby month less (iv) the price per Bbl of WTI for the third nearby NYMEX month, multiplied by .3333.

(c) Represent swap contracts that reduce the price volatility of forecasted ethane and propane sales by the Company at Mont Belvieu, Texas-posed prices.

Represent swaps that fix the basis differentials between the index price at which the Company sells its Gulf Coast,

(d) Mid-Continent and Permian Basin gas, respectively, and the NYMEX Henry Hub index price used in gas swap and collar contracts with short puts.

Interest rate derivatives. As of January 27, 2015, the Company was a party to interest rate derivative contracts whereby the Company will receive the 10-year Treasury rate in exchange for paying average fixed rates of 2.43 percent on a notional amount of \$200 million on June 30, 2015 and 2.37 percent on a notional amount of \$150 million on September 15, 2015.

Marketing and basis transfer derivatives. Periodically, the Company enters into buy and sell marketing arrangements to fulfill firm pipeline transportation commitments. Associated with these marketing arrangements, the Company may enter into index swaps to mitigate price risk. As of January 27, 2015, the Company had oil index swap contracts of 10,000 Bbls per day for 2015 with a price differential of \$2.99 per Bbl between Cushing WTI and Louisiana Light Sweet oil.
