Item 8.01. Other Events.

On November 7, 2011 Niel C. Ellerbrook, a member of the Board of Directors of Vectren Corporation adopted a stock trading plan in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934, as amended.

Under Rule 10b5-1, directors, officers, and other employees who are not in possession of material non-public information may adopt a pre-arranged plan or contract providing for the sale of Company securities under specified conditions and at specified times. Under 10b5-1 plans, an individual can gradually diversify their investment portfolios, spread stock trades out over an extended period of time to reduce market impact and avoid concerns about transactions occurring at a time when they might possess material non-public information.

Transactions under Mr. Ellerbrook's plan will not commence before November 15, 2011. The plan provides for the sale of up to 125,000 shares which will be acquired through the exercise of stock options. The plan will expire no later than December 31, 2012. Shares will be sold in the open market at prevailing market prices and subject to minimum price thresholds specified in the plan. The plan may be terminated or suspended if there are legal, contractual, or regulatory restrictions that would prohibit sales under the plan.

Mr. Ellerbrook advised the Company of his decision to implement the plan with respect to these options because they will expire on December 31, 2012. Transactions under the Plan will be disclosed publicly through Form 4 and Form 144 filings with the Securities and Exchange Commission.
