This Form 4 is being jointly filed by Bay Resource Partners, L.P., a Delaware limited partnership ("Bay"), Bay II Resource Partners, L.P., a Delaware limited partnership ("Bay II"), Bay Resource Partners Offshore Master Fund, L.P., an exempted limited partnership organized (1) under the laws of the Cayman Islands ("Offshore Fund"), GMT Capital Corp., a Georgia corporation ("GMT Capital"), and Thomas E. Clausus, a United States citizen ("Clausus"). The foregoing persons are hereinafter sometimes collectively referred to as the Reporting Persons.

GMT Capital, the general partner of Bay and Bay II, has the power to direct the affairs of Bay and Bay II, including the voting and disposition of shares. As the discretionary investment manager of the Offshore Fund and certain other accounts, GMT Capital has power to direct the voting and disposition of shares held by the Offshore Fund and such accounts. Mr. Clausus is the President of GMT Capital (2) and in that capacity directs the operations of each of Bay and Bay II and the voting and disposition of shares held by the Offshore Fund and separate client accounts managed by GMT Capital. GMT Capital and Mr. Clausus may be deemed to beneficially own indirect pecuniary interest as the result of performance-based fees and profit allocations. Each of GMT Capital and Mr. Clausus disclaims such beneficial ownership except to the extent ultimately realized.

The aggregate number of shares of common stock sold was 24,215 shares and such shares were sold by the Reporting Persons in the (3) following amounts: Bay = 3,400 shares; Bay II = 6,400 shares; Offshore Fund = 12,715 shares; GMT Capital = 1,000 shares; Clausus = 700 shares.

3,796,375 shares of common stock is the aggregate number of shares of common stock owned by the Reporting Persons and is owned as follows: Bay = 527,900 shares directly owned by it; Bay II = 996,000 shares directly owned by it; Offshore Fund = 2,008,275 shares directly owned by it; GMT Capital = 156,900 shares of common stock beneficially owned by it with respect to separate client accounts managed by it; Claugus = 107,300 shares directly owned by him.

- (5) The aggregate number of shares of common stock sold was 32,485 shares and such shares were sold by the Reporting Persons in the following amounts: Bay = 4,500 shares; Bay II = 8,500 shares; Offshore Fund = 17,285 shares; GMT Capital = 1,300 shares; Claugus = 900 shares.

- (6) 3,763,890 shares of common stock is the aggregate number of shares of common stock owned by the Reporting Persons and is owned as follows: Bay = 523,400 shares directly owned by it; Bay II = 987,500 shares directly owned by it; Offshore Fund = 1,990,990 shares directly owned by it; GMT Capital = 155,600 shares of common stock beneficially owned by it with respect to separate client accounts managed by it; Claugus = 106,400 shares directly owned by him.
