The number of shares of common stock offered hereby is based on a conversion rate of 16.1875 shares of common stock per \$1,000 principal amount of maturity of the Debentures. The number of shares of common stock owned by the other Selling Securityholders or any future transferee from any such holder assumes that they do not beneficially own any common stock other than common stock into which the Debentures are convertible at a conversion rate of 16.1875 shares of common stock per \$1,000 principal amount of maturity of the Debentures.

(2) Bear Stearns & Co. Inc ("Bear Stearns") was a joint bookrunning manager on the Debentures in December 2006. Bear Stearns through an affiliate has a \$50 million funding commitment under our Senior Credit Facility. As of March 2, 2007, \$4 million of this commitment was funded. Bear Stearns proprietary accounts were long 108,260 of our shares as of March 16, 2007.
