**Item 2.02. Results of Operations and Financial Condition.**

On July 20, 2010, the company issued a press release announcing financial results for the quarter ended June 30, 2010. Attached hereto as Exhibit 99.1 is a copy of the company's press release dated July 20, 2010 announcing the company's financial results for this period.

The press release also includes a discussion of operating expenses, operating revenue, logistics revenue, and operating expenses as a percentage of operating revenue, all net of fuel surcharge revenue. The company provided these additional disclosures because management believes removing these sources of revenue provides a more consistent basis for comparing results of operations from period to period. These financial measures in the press release have not been determined in accordance with generally accepted accounting principles ( GAAP ). Pursuant to Regulation G, the company has included a reconciliation of these non-GAAP financial measures to the most directly comparable GAAP financial measures. For the discussion of operating expenses, operating revenue, logistics revenue, and operating expenses as a percentage of operating revenue, all net of fuel surcharge revenue, the most directly comparable GAAP financial measures are operating expenses, operating revenue, logistics revenue, and operating expenses divided by operating revenue, respectively, which are reconciled in the attached Exhibit 99.1.
