EXPLANATORY NOTE

Pursuant to this Amendment No. 1 on Form 8-K/A, Blue Calypso, Inc. amends its Current Report on Form 8-K, filed with the Securities and Exchange Commission on January 20, 2012 (the Original Filing), to disclose the relationship between Blue Calypso, Inc. and Aztec Systems Inc. The remainder of the Original Filing remains unchanged from the original filing thereof.

Section 1 Registrant s Business and Operations

Item 1.01. Entry into a Material Definitive Agreement.

On January 16, 2012, Blue Calypso, Inc. (the <u>Company</u>) entered into a Letter Agreement (the <u>Letter Agreement</u>) with Aztec Systems Inc. (<u>Aztec</u>). Pursuant to the terms of the Letter Agreement, Aztec will extend credit to the Company in an amount requested by the Company up to a maximum of \$30,000 in any single month through March 31, 2012 to assist the Company with its ongoing software development efforts (the <u>Credit Extension</u>). In connection with the Credit Extension, the Company agreed to pay Aztec a minimum of \$30,000 per month beginning January 2012 to be applied against any amounts currently owed by the Company to Aztec or incurred in the future for software development and hosting services. Aztec may terminate the Credit Extension immediately upon notice to the Company.

Aztec is a corporation that provides administrative and technical support services to the Company. The majority owner of Aztec is Andrew Levi, the Company s chairman and chief executive officer.

Item 2.03. Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

On January 17, 2012, the Company issued a promissory note to Aztec in the principal amount of \$254,992.89 (the <u>Note</u>). The principal amount of the Note reflects the balance due by the Company to Aztec as of December 31, 2011 for software development and hosting services provided by Aztec to the Company. The Note bears interest at a rate of 8% per annum and the entire principal and interest under the Note is due on September 30, 2012. There is no penalty for prepayment of the Note by the Company.

In addition, pursuant to the Letter Agreement and in connection with the Credit Extension, the Company agreed to pay Aztec a minimum of \$30,000 per month beginning January 1, 2012 to be applied against any amounts currently owed by the Company to Aztec or incurred in the future for software development and hosting services.
