This report reflects shares received by the Reporting Person as a result of the Reporting Person's receipt of his pro rata portion of a special (1) distribution declared by the Board of Directors of the issuer on September 15, 2014 and paid on November 4, 2014 (the "Special Distribution").

(2) Includes 355 previously unreported shares (the "Shares") allocated on November 4, 2014 in connection with the Special Distribution. The Shares are issuable upon the settlement of restricted stock units ("RSUs") granted on May 29, 2014, which RSUs shall vest on the one year anniversary of the grant date (or, if earlier, the annual meeting of stockholders that is closest to the one year anniversary).

(3) Pursuant to the Reporting Person's election to participate in the Iron Mountain Incorporated Directors Deferred Compensation Plan, the shares of phantom stock (the "Phantom Shares") become payable in cash following the Reporting Person's disability or cessation of service as a director. Each Phantom Share is the economic equivalent of one share of common stock.

(4) These shares give effect to dividends paid on common stock as if reinvested in phantom stock.
