**Item 1.01 Entry into a Material Definitive Agreement**

On March 17, 2016, the registrant entered into an underwriting agreement ( Underwriting Agreement ) with Citigroup Global Markets Inc. and J.P. Morgan Securities LLC, as underwriters, relating to the offer and sale of \$100 million aggregate principal amount of the registrant's 4.500% notes due 2026 ( Notes ) in a reopening of the existing series of such Notes. The Notes are being offered and sold pursuant to the registrant's effective shelf registration statement on Form S-3 (File No. 333-187773) and prospectus supplement, dated March 17, 2016. The sale of the Notes is expected to close on March 22, 2016, subject to customary closing conditions.

The foregoing descriptions of the Underwriting Agreement and the Notes are qualified in their entirety by reference to the complete terms and conditions of the Underwriting Agreement and the form of the Notes, which are attached hereto as Exhibits 1.1 and 4.1, respectively, and incorporated herein by reference. A copy of the opinion and consent of Jonathan D. Kantor, Executive Vice President, General Counsel and Secretary of the registrant relating to the legality of the Notes to be issued and sold in the offering is filed as Exhibit 5.1 hereto.
