Vale informs on estimates update

Rio de Janeiro, October 26th, 2017 Vale S.A. (Vale), pursuant to the provisions set forth in Art. 157, paragraph 4 of the Law 6,404 of December 15, 1976, as amended, and the Instruction of *Comissão de Valores Mobiliários* (CVM) number 358 of January 3, 2002, as amended, informs that it updated today the following estimates: (i) net debt at the end of 2017 to the range between US\$ 15 billion and US\$ 17 billion, and (ii) capex in 2017 to US\$ 4.0 billion.

Vale informs that will file again in due course the item 11 of its Reference Form, in the period required by the Instruction CVM number 480 of December 7, 2009, as amended.

Vale clarifies that the information provided in this document represent only an expectation, hypothetical data that by no means constitute a promess of performace by Vale and/or its management. The estimates presented involve market factors which are not controlled by Vale and, therefore, can be subject to new changes.
