(the Company) issued a news release announcing that it commenced an offer to exchange its outstanding 5.500% Notes due 2041 for up to \$375 million aggregate principal amount of its newly issued 3.950% Notes due 2047 (the New Notes). The New Notes will be a further issuance of, and in addition to, the notes due 2047 that the Company expects to issue for cash on November 27, 2017, in the aggregate principal amount of \$325 million.
