- (1) The reporting person also indirectly owns 261 shares through the ADC Telecommunications, Inc. Retirement Savings Plan (401k) ("ADC 401k") based on a plan statement dated as of 11/30/08.
  - (2) Grant date 12/15/08; incentive stock options that vest one-quarter per year beginning on the first anniversary of the date of grant. Any unvested portions are subject to forfeiture upon termination of employment.
  - (3) Grant date 12/15/08; time based restricted stock units that vest fully on the third anniversary of the date of grant. These units of restricted stock will be settled one-for-one in shares of common stock upon vesting, provided that the reporting person remains an employee of the company on the vesting date.
  - (4) Grant date 12/15/08; time based restricted stock units that will vest over a five-year period from the date of the grant as follows: 20% on the third anniversary of the grant; 20% on the fourth anniversary of the grant; and 60% on the fifth anniversary of the grant. These units of restricted stock will be settled one-for-one in shares of common stock upon vesting, provided that the reporting person remains an employee of the company on the vesting dates.
