 - (1) Grant of salary stock in the form of mandatorily deferred Restricted Stock Units as approved by Sterling's board of directors on December 8, 2010. The 5,089 units granted on December 24, 2010 include those which were payable, subject to board approval, for pay periods taking place in the months of October, November and December of 2010, and retroactively issued upon receipt of board approval. Future RSUs are to be granted each payroll period and will be calculated using the closing price of Sterling's common stock on the NASDAQ Capital Market as of the last trading day in each payroll period.
 - (2) Units vest immediately upon grant, however, delivery of the awarded shares is deferred until future distribution dates provided in the Agreement between Sterling and Mr. Seibly.
