Performance shares and RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis.
- (2) Includes 1,000.92 Special Incentive Stock Ownership Premiums (SISOPs) (phantom stock) awarded pursuant to the PG&E Corporation Executive Stock Ownership Program, and reflects 9.78 SISOPs on 10/15/14 and 7.84 SISOPs on 1/15/15 acquired upon conversion of dividend equivalents received on those dates. SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met.
