The 2013 Performance Shares will be settled in shares of common stock
- (3) of the Company on March 15, 2016. As a condition to receiving the award, the reporting person agreed to hold, while employed by the Company and for at least one year after retirement, shares of Company common stock equal to at least 50% of the after-tax shares (assuming a 50% tax rate) acquired upon vesting.
- (4) The employee stock options, representing a right to purchase a total of 134,530 shares, became exercisable in three equal annual installments beginning on the first anniversary of the date of grant (2/27/2008).
