**Oncolytics Biotech's Research Collaborators to Present Data  
on REOLYSIN® Research at AACR-NCI-EORTC Conference**

**CALGARY, AB, October 5, 2005** Oncolytics Biotech Inc. ( Oncoytics ) (TSX:ONC, NASDAQ:ONCY) announced today that presentations covering various REOLYSIN® research programs will be made at the AACR-NCI-EORTC International Conference on Molecular Targets and Cancer Therapeutics: Discovery, Biology, and Clinical Applications, to be held November 14 to 18 in Philadelphia, Pennsylvania. A poster entitled A Phase I study of a wild-type reovirus (Reolysin) given intravenously to patients with advanced malignancies will be presented by Dr. Johann S. de Bono of The Royal Marsden Hospital and The Institute of Cancer Research, UK, and a poster entitled Reovirus enhances radiation cytotoxicity in vitro and in vivo will be presented by Dr. Kevin J. Harrington of the Targeted Therapy Laboratory, The Institute of Cancer Research, Cancer Research UK Centre for Cell and Molecular Biology, UK.

Oncolytics is a Calgary-based biotechnology company focused on the development of REOLYSIN®, its proprietary formulation of the human reovirus, as a potential cancer therapeutic. Oncolytics' researchers have demonstrated that the reovirus is able to selectively kill cancer cells and, *in vitro*, kill human cancer cells that are derived from many types of cancer including breast, bladder, prostate, pancreatic and brain tumours, and have also demonstrated successful cancer treatment results in a number of animal models. Phase I clinical trial results have indicated that REOLYSIN® was well tolerated and that the reovirus demonstrated activity in tumours injected with REOLYSIN®. *This press release contains forward-looking statements, within the meaning of Section 21E of the Securities Exchange Act of 1934, as amended.
