- (1) As a result of the merger between Halliburton and Boots and Coots, Inc., each share of issued and outstanding common stock of WEL was converted to cash and/or stock of Halliburton.

Each outstanding share of Boots & Coots common stock was converted into the right to receive: (1) approximately \$2.02 in cash and 0.0316 of a share of Halliburton common stock, for those Boots & Coots stockholders who made an election to receive all cash, (2)
 - (2) 0.0966 of a share of Halliburton common stock, for those Boots & Coots stockholders who elected to receive all stock and (3) \$1.72 in cash and 0.0412 of a share of Halliburton common stock, for those Boots Coots stockholders who received a combination of cash and stock.
 - (3) As a result of the merger between Halliburton and Boots and Coots, Inc., each outstanding stock option was converted to cash of \$3.00 per share net of the option price and applicable withholding taxes.
