All of the trustees share the voting and dispositive power with respect to the securities held by the Timken Foundation of Canton. 690,258 shares of the securities identified in this Schedule 13G are held by my wife, or trusts, or foundations other than the Timken Foundation of Canton. I disclaim the beneficial ownership of these securities except for 460,000 shares held in trust in which I have a one-sixth interest as a lifetime income beneficiary. I also disclaim beneficial ownership of the securities held by the Timken Foundation of Canton.
