- (1) The sales reported in this Form 4 were effected to cover tax withholding obligations upon vesting of 8,181 Restricted Share Units ("RSUs").

The reporting person undertakes to provide to Meritor, Inc. - (5) The date of grant of the RSUs was December 1, 2014. Each RSU represents the right to receive one share of common stock of the Company or its cash equivalent upon the vesting date, subject to the terms and conditions described in footnote 4 above.
