The Registrant estimates that its results of operations for the year ended December 31, 2014, as reflected in its consolidated statements of operations to be included in its Form 10-K for the year ended December 31, 2014, will reflect the following changes:

For the year ended December 31, 2014, the Registrant expects to report a decline in revenues to approximately \$31,000 from approximately \$43,000 for the year ended December 31, 2013. For the year ended December 31, 2014, the Registrant expects to report a net loss attributable to common stockholders of approximately \$987,000, compared to a net loss attributable to common stockholders of approximately \$1.65 million for the year ended December 31, 2013. The decrease in net loss for the year ended December 31, 2014 was largely attributable to the reduction in workforce and other operating expenses.

Also, for the year ended December 31, 2014, the Registrant expects to report net loss attributable to common stockholders per share - basic and diluted - of approximately \$0.01 compared to net loss attributable to common stockholders per share - basic and diluted - of \$0.02 for the year ended December 31, 2013.
