(In this attachment, the numbers stated for 2004 are preliminary, as the year-end audit is not completed)

Revenues in 2004 were \$13,130,579 compared to 2003 revenues of \$14,068,220 (a difference of \$937,641 or 7%). This decrease can predominantly be attributed to a \$240,000 promotional allowance booked in July 2004, not applicable in 2003, a decrease in revenue from a major customer in the first quarter of 2004 of approximately \$500,000, and a decrease in revenue from a customer who generated approximately \$420,000 in revenue in second quarter 2003 but did not produce any revenue in 2004.

Loss. In 2004 the Company had a loss of \$569,665, compared to net income of \$1,222 in 2003 (a difference of \$570,887). The loss most notably was caused by the reduced revenues discussed above, and lower gross profit. The reduction in gross profit is primarily due to increases in overhead, freight, and labor. Due to the move into a new building the company experienced excessive overtime labor costs in order to meet production demands.
