Mr. Baker was awarded performance rights representing the contingent right to receive between \$300,000 and \$1,200,000 worth of Hecla Mining Company common stock based on Hecla Mining Company's Total Shareholder Return performance over the 3-year period (January 1, 2018 to December 31, 2020) relative to our peers. Examples of the potential grant of shares to Mr. Baker under this plan are as follows: 100th percentile rank among peers = maximum award at 200% of target (\$1,200,000 in stock); 60th percentile rank among peers = target award at grant value (\$600,000 in stock); and 50th percentile rank among peers = threshold award at 50% of target (\$300,000 in stock).
 - (4) The number shown in Column 5 of Table II assumes a target payout (i.e., \$600,000 worth of common stock), with the common stock valued at the closing price on the day of the award (\$3.83). The actual number of shares received (if any) by Mr. Baker will depend on the Total Shareholder Return performance over the 3-year period and will be determined following the termination of that period.
