Item 1. Security and Issuer

(a) The Reporting Person beneficially owns 2,631,300 shares of Common Stock, which represents approximately 8.9% of the Company's outstanding shares of Common Stock.

The percentage ownership of shares of Common Stock set forth in this Schedule 13D is based on the 29,570,086 shares of Common Stock reported to be outstanding as of October 31, 2018 by the Company in its Form 10-Q as filed with Securities and Exchange Commission.
