SFNC shares will be delivered within 30 days of vesting. Events such as retirement, death, disability and other specified events in the agreement may result in earlier vesting.
- (2) The Restricted Stock Unit vested on May 1, 2019. 498 Restricted Stock Units vest on July 1, 2019; 497 Restricted Stock Units vest on October 1, 2019 and 498 Restricted Stock Units vest on January 2, 2020. SFNC shares will be delivered within 30 days of vesting. Events such as retirement, death, disability and other specified events in the agreement may result in earlier vesting.
- (3) Previously, shares of SFNC common stock beneficially owned directly by the Reporting Person ("Shares") were reported on separate lines to reflect their location in particular brokerage accounts. These Shares have now been consolidated into a single line.
