### G. WILLI-FOOD EXPECTS REVENUE GROWTH IN Q2 2013 TO EXCEED 20%

YAVNE, Israel – July 10, 2013 -- G. Willi-Food International Ltd. (NASDAQ: WILC) (the “Company” or “Willi-Food”), a global company that specializes in the development, marketing and international distribution of kosher foods, today announced that it expects quarterly revenue growth for the quarter ended June 30, 2013 to exceed 20% compared to revenue in the second quarter of 2012 based on a preliminary assesment of the financial results.

“In the second quarter we were again able to achieve strong organic growth as market demand for our kosher products continues to expand. We are increasingly gaining traction with new customers while product sales to existing customers continue to grow,” commented Zwi Williger, Chairman of Willi-Food. “Our financial results have significantly improved over the last twelve months, and our strategy to organically grow our customer base and product line is working. Moving forward we are looking to further leverage market demand to maximize financial performance.”

Willi-Food expects to release its financial results for the second quarter on August 12, 2013.
