(1) The shares sold were acquired contemporaneously upon the cashless exercise of a stock option at an exercise price of \$17.91 per share.

On November 27, 2007, the Reporting Person exercised his stock option to purchase common stock and sold the underlying shares. The sale reported on this Form 4 was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on August 27, 2007 (the "10b5-1 Plan"). Pursuant to the terms of the 10b5-1 Plan, the exercise of the stock option and sale of the underlying shares was supposed to occur on November 27, 2007. Due to broker error and with no involvement of the Reporting Person, the sale was not consummated until December 14, 2007. In order to comply with the 10b5-1 Plan, the Reporting Person will receive sale proceeds using the original sale price on November 27, 2007, \$39.64, the day the trade was originally set to occur under the 10b5-1 Plan.

(3) 25% of the total shares subject to the option vested on December 5, 2006, which was the first anniversary of the date of grant; the remaining shares vest in 36 equal monthly installments thereafter.
