- 7 1/2% Mandatory Convertible Subordinated Notes due 2013 ("Convertible Notes") will automatically convert into shares of common stock on January 15, 2013 (the "stated maturity date"); provided, however, that Mr. Salomon may elect to convert the Convertible Notes at any time prior to the stated maturity date.

Convertible Notes converted at Mr. Salomon's election prior to the stated maturity date will be converted at a rate of 4.4547 shares per \$25 principal amount, subject to adjustment in certain circumstances.
