- (1) On November 4, 2004, Mr. Kirshner entered into a Prepaid Forward Agreement ("Forward Agreement") relating to the forward sale of 5,000 shares of common stock of Markel Corporation ("Common Stock").
- (2) The Forward Agreement provided that 3 business days after November 5, 2007 (the "Maturity Date"), Mr. Kirshner would deliver a number of shares of Common Stock (or, at the election of Mr. Kirshner, the cash equivalent of such shares), based on the following: (a) if the closing price per share of Common Stock on the Maturity Date ("Final Price") was less than \$314.50 ("Floor Price"), Mr. Kirshner would deliver 5,000 shares; (b) if the Final Price was equal to or greater than the Floor Price but less than or equal to \$408.85 ("Cap Price"), Mr. Kirshner would deliver a number of shares equal to the Floor Price/Final Price x 5,000; and (c) if the Final Price was greater

than the Cap Price, Mr. Kirshner would deliver a number of shares equal to the product of the sum of $[(\text{Floor Price}/\text{Final Price}) + ((\text{Final Price} - \text{Cap Price})/\text{Final Price})] \times 5,000$. In consideration thereof, Mr. Kirshner received a price of \$1,320,900.

- (3) On November 5, 2007, Mr. Kirshner delivered 4,067 shares of Common Stock, and any potential delivery obligations regarding the remaining 933 shares of Common Stock subject to the Forward Agreement were extinguished.

Holdings under the Markel Corporation 401(K) Plan are reported in units. The information reported herein is based on a plan statement

- (4) dated as of September 28, 2007 and utilizes the closing stock price on that date of \$484.00. As of 9/28/2007, a unit under the Plan represented one share of Common Stock.
