- (2) One third (1/3rd) of the shares are fully vested on the date of grant, with the remaining shares vesting (starting on the one year anniversary of the date of grant) at a rate of one twenty-fourth (1/24th) per month until fully vested on September 3, 2012.
- (3) The reporting person agreed to cancellation of an option granted to him on July 21, 2006, in exchange for a new option having a lower exercise price.
- (4) The shares vest in three equal annual installments beginning on January 25, 2007.
- (5) One thirty-sixth (1/36th) of the shares shall vest and become exercisable in equal monthly installments starting on the monthly anniversary of the date of grant (November 19, 2008).
