Shares acquired pursuant to an Agreement and Plan of Merger between RehabCare Group, Inc. ("RehabCare") and Kindred Healthcare, Inc. ("Kindred"), pursuant to which RehabCare was merged with and into Kindred. As part of this merger, each issued and outstanding (1) share of RehabCare common stock (other than shares owned by Kindred or Rehabcare) were converted into the right to receive \$26.00 per share in cash and 0.471 shares of Kindred common stock. Prior to the effective time of the merger, Dr. Short directly owned 158,998 shares of RehabCare common stock.
