- (1) On 02/23/2010, the reporting person was granted an option to purchase 1,915,499 shares of Common Stock. The option vests based upon time (five equal annual installments that began on 02/23/2010) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.
- (2) As a result of the sale of shares by the Sponsors on 08/15/2012, the performance criteria was met with respect to 756,371 shares of common stock subject to this option award, resulting in vesting of the option as to 453,821 shares and an additional 302,550 shares that are eligible to vest in two equal annual installments beginning on 02/23/2013. In total, following this event, the performance criteria has been met with respect to all of the shares of common stock subject to this option award, with 1,149,297 of such shares vested and the remaining 766,202 of such shares eligible to vest in two equal annual installments beginning on 02/23/2013.
