- (1) 937 shares were withheld by the issuer to satisfy income tax withholding requirements related to the lapsing of restrictions on 3,427 shares of restricted stock awarded to the reporting person on June 27, 2011 (Form 4 filed on May 7, 2012). Because the reporting person's restricted stock holdings have been included in the direct ownership of Common Stock disclosed by the reporting person, the reporting person's direct ownership has been reduced by 937 to reflect this tax withholding.
- (2) 532 shares were withheld by the issuer to satisfy income tax withholding requirements related to the reporting person's receipt of 1,946 shares of Common Stock (which includes shares for previously reported Dividend Equivalent Units which were rounded up to whole shares upon payout) upon the payout of Restricted Common Stock Units awarded to the reporting person on May 18, 2010 (Form 4 filed on 5/10/2011).
