GlaxoSmithKline plc (the "Company") announces that in accordance with the authorities granted by shareholders at the Company's Annual General Meetings on 5 May 2011 and 3 May 2012 it purchased 1,300,000 of its Ordinary shares of 25 pence each ("shares") on 3 May 2012.
