- (1) Restricted shares awarded to Mr. Powers which will vest in two equal installments of 11,250 shares on March 15, 2006 and June 15, 2006.

Mr. Powers did not pay for the shares in question; they were awarded to him pursuant to the Issuer's non-employee director compensation policy. 12,500 shares were awarded for his service as a board member; and 6,250 were awarded for his service as Chairman of the Compensation Committee; and 3,750 were awarded for his service on the Audit Committee. The date of award was a federal holiday; on February 21, 2006, the next trading day, the closing price of the subject shares was \$0.41 per share.
