**ChipMOS REPORTS JULY 2008 REVENUES**

**Hsinchu, Taiwan, August 18, 2008** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenues for the month of July 2008.

Revenues for the month of July 2008 were NT\$1,555.9 million or US\$50.6 million, a decrease of 2.6% from the month of June 2008 and a decrease of 18.5% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$30.72 against US\$1.00 as of July 31, 2008.)
