On September 2, 2008, SRA International, Inc. (the Company) announced the sale of Constella Futures Holding, LLC (Constella Futures). Constella Futures was a wholly owned subsidiary of Constella Group, LLC, which was acquired by the Company in August 2007. Constella Futures was sold to a group of private investors led by former Constella Group, LLC Chairman & Chief Executive Officer, Donald A. Holzworth. The transaction is effective immediately.
