Item 1. Security and Issuer

The class of equity securities to which this Schedule 13D relates is the common stock, \$0.10 par value, of Croff Enterprises, Inc., a Utah corporation ( Company ). The address of the principal executive office of the Company is 345 North Maple Drive, Suite 208, Beverly Hills, CA 90210.

Item 2. Identity and Background.

Kimberly Sarubbi is a director of the Company. She is the President and sole director of Saddle Ranch Productions, Inc., a principal vendor of the Company. Her address is 8 Corral de Tierra Place, Henderson, NV 89052.

During the last five years, Ms. Sarubbi has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

During the last five years, Ms. Sarubbi has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding violation with respect to such laws.

Ms. Sarubbi is a citizen of the United States of America.

Item 3. Source and Amount of Funds or Other Consideration.

OO-Other. On July 27, 2009, a closing was held on the Agreement and Plan of Reorganization (the Agreement ) with AMHN Acquisition Corp., a newly formed Delaware corporation and wholly owned subsidiary of Croff ( Merger Sub ), America s Minority Health Network, Inc., a Delaware corporation ( America s Minority Health Network ) and the major shareholders of the American s Minority Health Network (the Major Shareholders ). The terms of the Agreement provide for (i) the transfer of 100% of the issued and outstanding shares of common stock of America s Minority Health Network in exchange for the issuance to the shareholders of American s Minority Health Network of an aggregate of 13,693,689 shares of common stock of Croff (the Croff Common Stock ) at a conversion ratio where one share of America s Minority Health Network is converted into 13,693.689 shares of Croff; (ii) the resignations of Croff s officers and directors prior to the consummation of the Agreement and the election and appointment of officers and directors as directed by America s Minority Health Network; and (iii) America s Minority Health Network to become a wholly owned subsidiary of Croff. The transaction is more fully outlined in the Form 8-K filed by the Company with the Securities and Exchange Commission on July 30, 2009.

As a Major Shareholder of America s Minority Health Network, Ms. Sarubbi was entitled to and did receive 4,108,107 shares of Croff Common Stock upon the closing of the transaction which shares were issued in the name of Saddle Ranch Productions, Inc. Taking into consideration the transaction outlined above, neither Ms. Sarubbi nor Saddle Ranch Productions, Inc. owned shares in the Company s Common Stock prior to the closing of the transaction, and after the closing of the transaction, Ms. Sarubbi beneficially owned 27.00% of the Company s 15,215,210 issued and outstanding shares.

Additional provisions of the Agreement called for the resignations of all directors and executive officers of the Company prior to the transaction and the election and appointment of new directors and executive officers. As such, Ms. Sarubbi became a director of the Company.

Item 4. Purpose of Transaction.

See Item 3 above.

Ms. Sarubbi is aware that the Company intends to change its name from Croff Enterprises, Inc. to America's Minority Health Network, Inc. in the near future.

Other than as outlined above, Ms. Sarubbi has no plans which relate to or would result in the acquisition by any person of additional securities of the issuer, or the disposition of securities of the issuer, an extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the issuer or any of its subsidiaries, a sale or transfer of a material amount of assets of the issuer or any of its subsidiaries, any change in the present board of directors or management of the issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board, any material change in the present capitalization or dividend policy of the issuer, any other material change in the issuer's business or corporate structure, including but not limited to, if the issuer is a registered closed-end investment company, any plans or proposals to make any changes in its investment policy for which a vote is required by Section 13 of the Investment Company Act of 1940, changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person, causing a class of securities of the issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association, a class of equity securities of the issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act, or any action similar to any of those enumerated above.

Item 5. Interest in Securities of Croff Enterprises, Inc.

(a) Kimberly Sarubbi indirectly owns 4,108,107 common shares, representing 27.00% of the class.

(b) Kimberly Sarubbi has sole power to vote or direct the vote and the power to dispose or to direct the disposition of the 4,108,107 shares of common stock owned by Saddle Ranch Productions, Inc. (See Rows 7-10 of the cover page.)
