**Explanatory Statement**

On November 25, 2003, Chordiant Software, Inc., a Delaware corporation (the Registrant ), filed a Registration Statement on Form S-8 (File No. 333-110743) (the Registration Statement), which registered 2,059,940 shares of the Registrant's common stock, par value \$0.001 per share (the Common Stock ) reserved for issuance under the 1999 Employee Stock Purchase Plan and the 1999 Non-Employee Directors' Stock Option Plan (collectively, the 1999 Plans ). This Post-Effective Amendment No. 1 is being filed to remove from registration all remaining authorized shares of Common Stock reserved for issuance under the 1999 Plans that have not yet been issued under the Registration Statement.
