**Smithfield Foods, Inc.'s Annual Meeting of Shareholders will be held on September 21, 2011 at the Williamsburg Lodge, 310 South England Street, Williamsburg, Virginia at 2:00 p.m. local time.**

**Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.**

**The Board of Directors recommends a vote FOR each of the nominees listed in Proposal 1, FOR Proposals 2 and 3, for every ONE YEAR for Proposal 4, and AGAINST Proposal 5.**

1. Election of three directors to serve three-year terms and one director to serve a two-year term.
2. Ratification of the selection of Ernst & Young LLP as independent auditors of the Company for the fiscal year ending April 29, 2012.
3. An advisory vote regarding the approval of compensation paid to certain executive officers.
4. An advisory vote regarding the frequency of shareholder approval of the compensation paid to certain executive officers.
5. A shareholder proposal regarding the declassification of the Board of Directors, if presented.
6. The transaction of such other business as may properly come before the meeting or any continuation or adjournment thereof.
