This Schedule 13G is being filed on behalf of BlueMountain Capital Management, LLC (**BMCM**) and BlueMountain GP Holdings, LLC (**GP Holdings**) and together with BMCM, the **Reporting Persons**) with respect to the shares of Class A Common Stock, par value \$0.01 per share (the **Class A Common Stock**) of The McClatchy Company, a Delaware corporation (the **Issuer**).

BMCM acts as investment manager to, and exercises investment discretion with respect to the Class A Common Stock directly owned by, the following entities:

- (i) Blue Mountain Credit Alternatives Master Fund L.P., a Cayman Islands exempted limited partnership (**Credit Alternatives**) with respect to the 2,636,283 shares of Class A Common Stock directly owned by it;
- (ii) BlueMountain Long/Short Credit Master Fund L.P., a Cayman Islands exempted limited partnership (**Long/Short Credit**) with respect to the 910,022 shares of Class A Common Stock directly owned by it;
- (iii) BlueMountain Distressed Master Fund L.P., a Cayman Islands exempted limited partnership (**Distressed**) and together with Credit Alternatives and Long/Short Credit, the **Partnerships**) with respect to the 501,663 shares of Class A Common Stock directly owned by it; and
- (iv) BlueMountain Timberline Ltd., a Cayman Islands exempted limited company, with respect to the 508,842 shares of Class A Common Stock directly owned by it.

GP Holdings serves as the ultimate general partner of each of the Partnerships, with respect to the Class A Common Stock directly owned by each of the Partnerships.

The filing of this statement should not be construed as an admission that any of the Reporting Persons is, for the purpose of Section 13 of the Act, the beneficial owner of the Class A Common Stock reported herein.
