Of the 43,246,306 shares of the Company s common stock outstanding as of September 6, 2013 (the record date), 40,828,486 shares, or 94.41%, were present or represented by proxy at the meeting. Three proposals were considered at the meeting.

<u>Proposal One</u>. The stockholders elected the Company s two Class I nominees to the Company s Board of Directors to each serve for a three-year term, each until his successor is duly elected and qualified. The table below presents the results of the election:
