The Company became a large accelerated filer on December 31, 2013, which means that it no longer qualifies for certain exemptions provided under the JOBS Act relative to Section 404(b) of the Sarbanes-Oxley Act and will be required, for the first time, to include in its 2013 Annual Report on Form 10-K a report from its independent public accounting firm expressing its opinion as to the Company's internal control over financial reporting (as defined in Rule 13a-15(f) and Rule 15d-15(f) under the Exchange Act). Procedures relating to the assessment of the Company's internal control over financial reporting are not yet complete. As a result, the Company is not able to file its Annual Report on Form 10-K for the fiscal year ended December 31, 2013 by the prescribed due date of March 3, 2014. The Company cannot eliminate the reasons causing the inability to file timely without unreasonable effort or expense.
