**Item 2.02. Results of Operations and Financial Condition.**

On April 28, 2016, CommScope Holding Company, Inc. ( CommScope ) issued a press release relating to its financial results for the first quarter of 2016. A copy of the press release, which is incorporated by reference herein, is attached hereto as Exhibit 99.1. Following the publication of the press release, CommScope will host an earnings call during which its financial results for the first quarter of 2016 will be discussed.

**Item 7.01 Regulation FD.**

On April 28, 2016, CommScope delivered a redemption notice (the Notice ) to the trustee with respect to its 6.625%/7.375% Senior PIK Toggle Notes due 2020 (the Holdco Notes ). Pursuant to the Notice, the Issuer gave holders of the Holdco Notes notice that it will redeem \$300,000,000 in outstanding aggregate principal amount of the Holdco Notes on June 1, 2016 (the Redemption Date ). The Holdco Notes selected for redemption will be redeemed at a redemption price of 103.313% of the principal amount thereof (the Redemption Price ) plus accrued and unpaid interest thereon to the Redemption Date. After such redemption, \$236,630,000 in aggregate principal amount of Holdco Notes will remain outstanding.
