CommScope Announces Sale of 20 Million Shares of Common Stock by Affiliate of The Carlyle Group

HICKORY, NC, May 2, 2016 CommScope Holding Company, Inc. (NASDAQ: COMM) has announced the sale of 20 million shares of its common stock on an underwritten basis by an affiliate of The Carlyle Group. In addition, the underwriters will have an option to purchase up to three million additional shares from Carlyle. CommScope will not receive any of the proceeds from the offering of shares by Carlyle. Closing of the offering is expected to occur on or about May 6, 2016, subject to customary closing conditions.

Barclays and Credit Suisse Securities (USA) LLC are acting as the joint book-running managers for the offering. Barclays and Credit Suisse Securities (USA) LLC propose to offer the shares of common stock to the public at a fixed price, which may be changed at any time without notice.

Following the offering, Carlyle will continue to beneficially own 41,216,970 shares, or approximately 21%, of CommScope's outstanding common stock after giving effect to the offering (or 38,216,970 shares, or approximately 20%, if the underwriters fully exercise their option to purchase additional shares).

CommScope has filed an automatically effective registration statement (including a prospectus) with the U.S. Securities and Exchange Commission for the offering to which this communication relates, and the offering may only be made by means of such written prospectus.
