On September 21, 2016, at the Issuer's request, Master Account, Capital Partners (100) and Institutional Partners III (collectively, the <u>MHR</u> <u>Funds</u>) agreed to the Issuer's request to waive their rights under that certain Registration Rights Agreement, dated October 5, 2012, by and among the Issuer and the MHR Funds (the <u>Registration Agreement</u>), to include securities held by them as selling securityholders in the Issuer's registration statement on Form S-3, filed on September 22, 2016 (the <u>Registration Statement</u>), or in any subsequent offering by the Issuer with respect to the Issuer's securities registered under such Registration Statement. At the same time, the MHR Funds and the Issuer entered into Amendment No. 1 to the Registration Agreement (<u>Amendment No.</u> 1), pursuant to which the aggregate number of demand registrations that the Issuer is obliged to effect on behalf of the MHR Funds increased from three to four.
