On September 21, 2017, the Registrant announced the rebranding of its wholly-owned commercial bank subsidiary, The Citizens Savings Bank (the Bank), under the name Unified Bank. This initiative, which is set to become effective October 10, 2017, will consolidate the Bank's operations under a single brand. Currently, the Bank operates its eighteen full service banking offices under two geographic divisions; using the trade names The Citizens Bank and The Community Bank.
